## The Chad/Rick Payson Memorial Scholarship Youth Pro-Am

- FORMAT.** This is a Singles Tournament open to all YABA eligible bowlers with four average divisions:  
Division 1 – 130 and below      Division 2 – 131 through 160      Division 3 – 161 and above      Scratch
- AVERAGES.** It is each bowler's responsibility to verify the accuracy of his/her average. In order to compete under Ruling A, B, or C, the bowler MUST have a verifiable league average. Tournament averages will be determined in the following order:  
**Ruling A.** Bowlers will use their highest 2007-2008 yearbook average based on a minimum of 21 games. Youth bowlers from outside the Greater Austin Area USBC Association must provide a copy of the page from the association's yearbook used to obtain the entering average with the completed entry form.  
**Ruling B.** Bowlers not having a 2007-2008 yearbook average will use their September 14, 2008 average of 12 or more games. A copy of the League Standing Sheet must be provided to the Tournament Director at the time of participation.  
**Ruling C.** Bowlers not qualifying under Ruling A or B will use their highest 2008 final Summer League average of 15 or more games with the League Secretary's verification. A copy of the final League Standing Sheet must be provided to the Tournament Director with the completed entry form.  
**Ruling D.** Any bowler not qualifying under Ruling A, B or C will be assigned a 220 average.  
**Any bowler who does not provide proof of average must bowl with a 220 average in either Division 3 or the Scratch Division.**
- HANDICAP.** The handicap allowance is 90% of the difference between each youth bowler's tournament average and a scratch score of 220.
- SCORING.** Total pins for three games plus handicap will be used to determine the standings. The professional bowlers will bowl with the youth participants, moving a pair of lanes to the right after each five frames. Their scores will not be used to determine the standings.
- AWARDS.** Scholarships will be awarded on the basis of one scholarship for every three entries in each of the 4 divisions. A **minimum** of \$300.00 will be awarded for First Place in each division. Scholarships are managed by SMART.
- ENTRY FEES.** The entry fee is \$70.00 per bowler. Each bowler will receive a **BRUNSWICK POWER GROOVE** bowling ball and a **BRUNSWICK** bowling towel. A bowler may choose to upgrade to a **BRUNSWICK PERFORMANCE LINE BALL** for an additional fee of \$20.00 (\$90.00 total entry fee) or to a **BRUNSWICK PRO PERFORMANCE LINE BALL** for an additional \$35.00 (\$105.00 total entry fee). Entry fees are not refundable. Incomplete entries are not accepted. All entry fees (including the cost of any selected upgrade) must accompany the completed entry form. Make Check of Money Order payable to: **JAMMY B's Promotions**.
- CLOSING DATE FOR ENTRIES.** The closing date for entries is September 15, 2008. **Entries received by Monday, August 25, 2008 will be eligible to receive the bowling ball on the day of the event. Delivery of the ball is not guaranteed but all attempts will be made to insure availability at the time of participation in the tournament.** Entries will be accepted after the closing date provided squad times are available. The Tournament Committee reserves the right to add or delete squads. Multiple entries will be allowed.  
**NOTE: It will be the bowler's responsibility to pick up bowling balls delivered after the day of the tournament. Ball will be shipped upon request for an additional fee of \$20.00.**
- CHECK-IN.** Bowlers must check in 30 minutes prior to squad time. Squads start as scheduled and tardy players receive zero for frames missed.
- SUBSTITUTES.** A substitute may be used in the event of injury, illness or the absenteeism of the scheduled bowler. The replacement bowler will compete in his or her own average division based on the average rule stated above.
- MISCELLANEOUS.** Bowlers are required to stay in the bowler's settee area. There will be no use of tobacco or consumption of alcohol beverages by participants.
